Further to the above noted matter, attached please find the Redacted version of the 2023 Audited Financial Statements December 31, 2023 with Attachment 5 (the HCl3 financial statements) no longer redacted, as per the McInnes Cooper Erratum letter to the NSUARB on May 13.

I note the NSUARB reference on our earlier exchange of correspondence referred to Matter M11678 – EOne Affiliate Code of Conduct. I believe this confusion arose from the request for confidentiality accompanying the original filing of the Financial Statements and Code of Conduct reports; while the documents were filed separately, the same transmittal letter accompanied both. This document should be re-filed under M11677 – 2023 Audited Financial Statements – December 31, 2023, rather than M11678 as referenced in our earlier correspondence.
