AMENDED HEARING ORDER

NS Power applied to the Nova Scotia Energy Board on September 18, 2025, for approval of certain revisions to its Rates, Charges and Regulations.

The Board orders that:

1. The public hearing for this matter will start on **Wednesday, January 7, 2026, at 9:00 am**, at the **Offices of the Board, Summit Place, 3rd Floor, 1601 Lower Water Street, Halifax, Nova Scotia**, and continue until **Friday, January 16, 2026, if necessary**.
2. There will be an **evening session on Thursday, January 8, 2026, at 6:30 pm, provided there are registered speakers by the deadline of Thursday, November 27, 2026**.

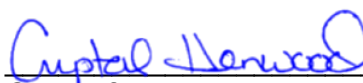
