Dear Ms. Henwood,

The Board has finalized the issues list this week, amended the deadline for filing Notices of Intervention to October 30, 2025, but maintained the timeline for Information Requests to NS Power to be filed October 22, 2025.

On behalf of Renewall Energy Inc. I filed a Notice of Intervention last week, October 15, 2025. Renewall was not a party to any settlement and we are still reviewing the application to prepare questions for NS Power. Renewall is presently focused on urgent corporate matters and due to resource constraints, we are unable to meet today's deadline for IRs.

We respectfully request that Renewall be provided a one-week extension to file its IRs to NS Power, to October 28, 2025. It is also reasonably possible that after reviewing the IRs that will be filed in advance, it will abbreviate or eliminate questions from Renewall.
