Your email "for completeness" is a formal administrative admission that Nova Scotia
Power completely failed to follow proper tribunal procedures and executed an illegal, non-
compliant split filing.

I am noting that you also deliberately stripped the investigative media desks and elected
officials off the distribution chain. I am manually re-adding every single one of them to this
thread. The public record will not be managed or sanitized in secret behind closed doors to
suit the Board's convenience.

The fact that you had to personally step in to send me the contents of Exhibit L-11 proves
the untrustworthy and non-compliant nature of this utility. Yet, instead of holding them
accountable for these clear violations and regulatory failures, the Board is choosing to fix
their mistakes after the fact and allow this charade to continue.

Providing the files now does not cure the core statutory crisis: **Nova Scotia Power has still
failed to produce a single signed agreement required by Regulation 6.5(3).**

Their own data logs confirm that no signed contracts exist on my file. The legal ramification
of a void contract is absolute: the entire balance is nullified, and the utility is legally
required to pay back each and every cent taken under these unexecuted structures.

The Board is holding a multi-billion-dollar monopoly to a completely different standard
than a citizen. You are allowing them to execute a **\$1,776.00 collections demand** on an
account where their evidence has completely collapsed. I am renewing my demand for
an **Immediate Emergency Stay Order** to stop this predatory billing while this entire broken
process is investigated.

I have attached your email for proof of the blatant double standards this board is allowing to continue to abuse and bully a disabled veteran they have already stolen from and admitted in their own writings to overcharging let alone the fact not a single signed agreement has been provided proving they are legally responsible to refund every single cent they have stolen from my family.
