Ms. Wallace and Board Staff,

I am writing to formally place on the record that by failing to immediately issue an Emergency Stay of Enforcement, which I have been requesting for months now, this Board is actively enabling severe economic duress against my family.

This morning, your office officially acknowledged and logged Exhibit L-9 LINCOLN (NSEB) RIR-1. That exhibit contains Nova Scotia Power's own documentation, which provides the absolute mathematical proof of direct triple-billing, data manipulation, and contracts that completely lack the customer signatures mandated by Regulation 6.5(3).

The evidence proving these violations came directly from Nova Scotia Power's own submission. The utility has been caught lying to me, lying to the Dispute Resolution Officer, and submitting fraudulent metrics to this Board.

It is completely unacceptable that the Board continues to follow a slow, procedural paperwork charade while possessing black-and-white proof that a regulated monopoly has unlawfully extracted between \$20,000.00 and \$50,000.00 from my family.

By forcing a disabled veteran managing service-connected injuries to endure continued procedural delays while Nova Scotia Power runs an active collection clock to demand \$1,776.00 by June 8th, you are actively weaponizing your own administrative backlog to cause direct financial and physical harm.

The burden of proof has been failed by the utility for months. The evidence of fraud is now completely verified on your own public portal. I demand that this Board stop enabling a lawless monopoly, immediately action my request, and issue an Immediate Emergency Stay Order to freeze this account. Start a full forensic audit and start the full restitution for the clear stolen funds Nova Scotia Power has been allowed to get away with while being enabled by the board even with mountains of clear black and white evidence proving not only regulatory failure and multiple unlawful acts.

This matter isnt just the responsibility of the board to regulate a lawless monopoly but to also protect the consumers that this monopoly is clearly in multiple ways cheating and stealing from. This systemic failure is not only in my interest after clearly proving all of these violations but in the provincial public interest as there are at minimum 13000 others they are currently doing the same things to about to hit a massive class action against NSP and anyone enabling the failures of this lawless monopoly and not supporting the protections by law given to consumers, which are currently being violated by the enabling of NSP's actions.
