I am formally submitting the complete, unedited correspondence chain between my office and the Office of the Prime Minister of Canada to supplement **Exhibit L-9 LINCOLN (NSEB) RIR-1**.

The Prime Minister's Office has formally directed me to hold **Premier Tim Houston personally accountable** for this regulatory collapse, explicitly instructing me to escalate this matter directly to his desk.

Premier Houston, the federal government has just passed the buck squarely to you. You can no longer hide behind the pretense of an independent tribunal. The highest office in this country has read the proof of Nova Scotia Power's systemic triple-billing fraud and has

named you as the ultimate authority responsible for this lawless monopoly that has unlawfully extracted between \$20,000.00 and \$50,000.00 from my family.

As my direct reply to the Prime Minister documents below, your office has actively deleted at least three of my forensic email pleas without reading them—a fact I have mathematically verified as a former Computer Technician who spent nearly 8 years of my career at NORAD.

To all 12 investigative news desks on this line: look at the complete collapse of institutional accountability. The utility provider triple-bills a disabled veteran for \$4,818.00 when their own computer logs the true energy cost at \$782.82. The Energy Board accepts secret files and refuses to issue a Stay. The provincial government deletes the veteran's emails, and the Prime Minister's Office issues a boilerplate jurisdictional hand-off while Scotiabank blocks my mortgage payments for 460+ days.

My 48-hour clock is running. If this Board does not immediately void this fabricated balance and issue an Immediate Emergency Stay Order by the end of day Wednesday, May 27th, this entire cross-governmental record of capture, bias, and institutional neglect will be filed directly before the Nova Scotia Court of Appeal.

I will also note for anyone who thinks ill back down or go away, i currently have another matter in front of both the OBSI and the NS Bar and the NS AG i will not accept anything less than full accountability for all. Again all proven violations of my rights, regulatory failures and unlawful actions all in black and white exactly the same as this matter.
