

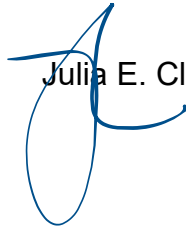
NOVA SCOTIA REGULATORY AND APPEALS BOARD

HEARING ORDER

The Town of Lunenburg, on behalf of its Water Utility applied to the Nova Scotia Regulatory and Appeals Board on March 20, 2026, for approval of amendments to the Utility's Schedule of Rates and Charges for water and water services and amendments to its Schedule of Rules and Regulations.

The Board orders that:
