O R D E R

WHEREAS:

1. By Order dated April 8, 2013 in Matter 192 and as modified by subsequent Orders dated October 27, 2023 and December 12, 2025 in Matter 561, the Board established a fuel surcharge mechanism used to determine the quarterly fuel surcharge to be added to passenger fares for Coach Atlantic's inter-city motor coach service.
2. The average New York Harbour spot price for ultra-low sulphur diesel fuel (ULSD) for the period January 1, 2010 through June 30, 2010, or the "Base Price", was 59.3 cents per litre.
3. The average New York Harbour daily spot price for ULSD for the period January 1, 2026 through March 31, 2026 was 120.09 cents per litre, the federal fuel charge for ULSD is 0.0 cents per litre and the average cost of carbon / *Clean Fuel Regulations* compliance cost in the wholesale margin was 8.81 cents per litre, resulting in an average cost of ULSD of 128.90 cents per litre, which is a 69.60 cent per litre increase in the cost of ULSD versus the Base Price.
4. The fuel surcharge methodology permits Coach Atlantic to assess a fuel surcharge to passenger fares of 0.5 % for each 2.5 cent incremental increase in the price of ULSD over the base price.
5. The fuel surcharge methodology results in a fuel surcharge of 13.5%.

IT IS HEREBY ORDERED THAT:

1. Effective April 15, 2026, until further order of the Board, the fuel surcharge is set at 13.5% for all passenger fares for inter-city motor coach service provided by Coach Atlantic. The approved schedule of fares, incorporating the current surcharge, is attached as Schedule A.
