NOTICE OF INTERVENTION

Take Notice that Nova Scotia Power Inc. (“NS Power”) requests to intervene in this proceeding in accordance with Rule 11(1) of the Board Regulatory Rules.

NS Power is a regulated public utility engaged in the generation, transmission and distribution of electrical power to approximately 500,000 customers in Nova Scotia. NS Power is a public utility within the definition of the *Public Utilities Act*.

NS Power is the utility which Contracts with EfficiencyOne for the provision of Demand-Side Management and the DSM Plan Contract. Nova Scotia Power is the utility which recovers the DSM costs from customers and pays EfficiencyOne for the services.

NS Power intends to appear at the oral hearing of this matter and, should it deem necessary, NS Power intends to address all issues relevant to its interests, rights, and role as a public utility, including any issues identified by the Nova Scotia Utility and Review Board or that may otherwise arise in the course of the proceeding.
