Good afternoon,

E1's preference is that due process be followed and its witnesses provide their evidence before intervenor evidence is provided, pursuant to section 22(3) of the Board Regulatory Rules.

In the interest of accommodating the intervenors, and in line with the ability for hearings to be conducted in an informal manner, E1 is willing to arrange for Mr. Love to present his evidence on August 6th or 7th and for Ms. Sergici to provide her evidence on the morning of August 6th. Given timing constraints in the morning of August 6th, and depending on the amount of questions that will be presented to Ms. Sergici, E1 would be willing to accommodate a late afternoon start for Ms. Sergici's testimony on August 5th.

In the event the cross-examination of the E1 witnesses is not complete before the time of Ms. Sergici's testimony, the E1 examination could resume after Ms. Sergici provides her evidence. However, it is E1's strong preference to try to ensure the E1 witnesses complete their evidence before any intervenor evidence is presented.

E1's position on these accommodations is intended to be exceptional, for this proceeding only.
